The Ak-Chin Indian Community ("Community") has available an arena within which rodeo events are hosted. Members of the public who choose to participate in rodeo events hosted within the Community must sign this Release and Waiver in exchange for permission to participate.

RELEASE AND WAIVER

I understand that I am being granted permission to use the Community's rodeo arena and participate in events held therein. I further understand that the Ak-Chin Indian Community ("Community") is neither obligated to provide access to the arena nor to allow me to participate in any rodeo event held within the Community.

I understand that the Community, by providing the arena, hosting rodeo events, contracting with rodeo promoters and stock contractors, and in obtaining liability and other insurance, does not waive its sovereign immunity nor does it consent to suit.

I understand and intend that my signature on this Release and Waiver and my subsequent use of the Community's rodeo arena and participation in any rodeo event shall be deemed attestation of my understanding and voluntary acceptance of the risks associated with using the rodeo arena and in participating in rodeo events, and that I waive all claims I, my assigns, and my heirs may have against the Community and its officers or employees for loss, injury, accident, illness, or death occurring during or by reason of my use of the rodeo arena or my participation in any rodeo event.

I understand that rodeo events are **inherently dangerous and that injury or death can be caused** due to my participation in such events. I further understand that I am solely responsible for ensuring my own safety if I choose to participate in such rodeo events.

I HEREBY RELEASE, DISCHARGE, AND INDEMNIFY THE AK-CHIN INDIAN COMMUNITY, AND ITS SUBSIDIARIES AND AFFILIATES (WHICH SHALL BE INTERPRETED TO INCLUDE **AK-CHIN CIRCLE AND HARRAH'S AK-CHIN**), AND THEIR RESPECTIVE OFFICERS, EMPLOYEES AND AGENTS (COLLECTIVELY "COMMUNITY") FROM, AND COVENANT NOT TO SUE THE COMMUNITY FOR, ANY AND ALL LOSS OR DAMAGE ON ACCOUNT OF INJURY TO MY PERSON OR MY PROPERTY OR RESULTING IN MY INJURY OR DEATH (COLLECTIVELY "INJURY"), REGARDLESS OF WHETHER OR NOT SUCH INJURY IS CAUSED BY THE NEGLIGENCE OF THE COMMUNITY. FURTHER, I HEREBY VOLUNTARILY WAIVE ANY RIGHT TO BRING A CLAIM RESULTING FROM THE ORDINARY NEGLIGENCE OF THE COMMUNITY, BOTH PRESENT AND FUTURE, THAT MAY BE MADE BY ME, MY FAMILY, ESTATE, HEIRS OR ASSIGNS.
