I understand that the Community, by providing the arena, hosting rodeo events, contracting with rodeo promoters and stock contractors, and in obtaining liability and other insurance, does not waive its sovereign immunity nor does it consent to suit.

I understand and intend that my signature on this Release and Waiver and my subsequent use of the Community's rodeo arena and participation in any rodeo event shall be deemed attestation of my understanding and voluntary acceptance of the risks associated with using the rodeo arena and in participating in rodeo events, and that I waive all claims I, my assigns, and my heirs may have against the Community and its officers or employees for loss, injury, accident, illness, or death occurring during or by reason of my use of the rodeo arena or my participation in any rodeo event.

I understand that rodeo events are <u>inherently dangerous and that injury or death can be caused</u> due to my participation in such events. I further understand that I am solely responsible for ensuring my own safety if I choose to participate in such rodeo events.
